April - May 2011	<ul style="list-style-type: none"> <li>Students submit their applications to their home HEI, which sets its own internal application deadline.</li> </ul>
<b>FOR COURSES STARTING IN SUMMER/AUTUMN 2011</b>	
<b>1<sup>st</sup> June 2011</b>	<ul style="list-style-type: none"> <li>Deadline for HEIs to send student applications with their confirmation by e-mail<sup>1</sup> to EILC Organising Institutions and a list of applicants to their home National Agency (NA).</li> </ul>
Early June 2011	<ul style="list-style-type: none"> <li>OIs select applicants in co-operation with their home NA.</li> </ul>
<b>22<sup>nd</sup> June 2011</b>	<ul style="list-style-type: none"> <li>Deadline for EILC Organising Institutions to send a list of selected, rejected and reserve students to sending HEIs.</li> <li>EILC Organising Institutions inform all applicants - including the selected, reserve and rejected students – about the selection results.</li> </ul>
Late June/early July 2011	<ul style="list-style-type: none"> <li>Selected Erasmus students send confirmation of participation in EILCs to the EILC Organising Institutions through their HEI's Erasmus office.</li> <li>EILC Organising Institutions send the info-package to "confirmed EILC students".</li> </ul>
June - August 2011	<ul style="list-style-type: none"> <li><i>Comenius/Grundtvig Assistants</i> apply to the EILC Organising Institution as soon as their <i>Comenius/Grundtvig Assistant</i> status has been confirmed.</li> </ul>
July/August 2011	<ul style="list-style-type: none"> <li>EILC Organising Institutions select reserve students in case of withdrawals.</li> <li><i>Comenius/Grundtvig Assistants</i> to be informed about selection results.</li> </ul>
<b>FOR COURSES STARTING IN WINTER/SPRING 2012</b>	
<b>30<sup>th</sup> October 2011</b>	<ul style="list-style-type: none"> <li>Deadline for HEIs to send student applications to EILC Organising Institutions and a list of applicants to their home NA.</li> <li>Deadline for <i>Comenius/Grundtvig Assistants</i> to apply to the EILC Organising Institution.<sup>2</sup></li> </ul>
Early November 2011	<ul style="list-style-type: none"> <li>EILC Organising Institutions select applicants in co-operation with their home NA.</li> </ul>
<b>20<sup>th</sup> November 2011</b>	<ul style="list-style-type: none"> <li>Deadline for EILC Organising Institutions to send a list of selected and reserve students to sending HEIs.</li> <li>EILC Organising Institutions inform all applicants - including the selected, reserve and rejected students - about the selection results.</li> </ul>
Late November/early December 2011	<ul style="list-style-type: none"> <li>Selected Erasmus students send confirmation of participation in EILCs to the EILC Organising Institutions through their HEI's Erasmus office.</li> <li>EILC Organising Institutions send the info-package to "confirmed EILC students".</li> </ul>
December 2011 / January 2012	<ul style="list-style-type: none"> <li>EILC Organising Institutions select reserve students in case of withdrawals.</li> </ul>
