### SHORT CV OF THE SUPERVISOR

Paulo Teodoro de Matos was born in Lisbon, 1974. He has a PhD in Historical Demography from Universidade do Minho (2004). As a post-doctoral researcher he has developed the post-doctoral projects 'Goa from the Ancién Regime to the Liberalism: Demography, family and inheritance, 1720-1830' (Universidade Católica Portuguesa/University of Goa) and 'Demographic Trends of the Portuguese Atlantic, 1750-1820' (Universidade Nova de Lisboa/The Johns Hopkins University).

Since 2009 he is a Research Fellow of the Centre for Overseas History (Universidade Nova de Lisboa - Universidade dos Açores). His main research activities are related to Historical demography, social history and History of the Portuguese Expansion. He is the Executive Coordinator of the Master in History of the Portuguese Empire (FCSH/Nova) and Director of the research project Counting Colonial Populations.
