

## Public Notice - Full Professor

Notice n. ° 543/2018 published in *Diário da República*, 2nd series, n. ° 102, 28/05

Qualifications based applications are being accepted for 2 posts of Full Professor in the 2nd Group Subject Area - Private Law

Pursuant to article 39 of the Statute of the University Teaching Career (ECDU in the original Portuguese) approved by Decree-Law No. 448/79 of 13 November, in the current wording, by delegation of powers, the Director of Universidade Nova de Lisboa Law School, Professor Teresa Pizarro Beleza, following the administrative Order of 5/02/2018 by the Dean of Universidade Nova de Lisboa, Professor João Sàágua, hereby announces the opening of a qualification-based application process for a period of 30 business days, as of the date immediately after the publication of this Notice in the Portuguese '*Diário da República*', to recruit 2 Full Professors in the 2nd Group Subject Area - Private Law (all the subject areas of this group provided in point 5.2 of the annex to the Administrative Order No. 6444/2015, published in the DR, 2nd series, No. 111 of 9 June) for the Universidade Nova de Lisboa Law School.

This qualification-based call for applications is international and is governed by the provisions in articles 37 *et seq* of the Statute along with the University Teaching Career Tender Regulations at UNL, (Regulation No. 3012/2015 published in the 2nd series of the '*Diário da República*' No. 58 of 24 March) and the Regulation of the University Teaching Career Application Regulations at UNL (Regulation No 115/2013, published in the 2nd series of the '*Diário da República*' No. 59 of 25 March).

I - Application requirements:

1 - To comply with the general conditions for public sector recruitment.

2 - Pursuant to article 40 of the ECDU, the applicants must:

- a) Have had a doctoral degree for more than 5 years;
- b) Have the Portuguese title of "Agregado".

3 - The applicants must have a doctoral degree in the area of Private Law.

II - Deadline for the validity of the call for applications: The call is valid for applications for these posts and expires when they are filled.

### III - Application presentation:

1 - Applicants must present the application requirements preferably in a digital support (Thumb drive) in person to the Human Resources Service of the Universidade Nova de Lisboa Law School at Campus de Campolide, 1099-032 Lisbon, or by post to the same address.

2 - The application must be accompanied by the following documents:

- a) Application form, using the form provided online at <http://www.fd.unl.pt/Anexos/12367.pdf>.
- b) Certificate proving their doctor's degree was obtained at least 5 years ago in the subject areas covered by the call for applications;
- c) A certificate proving they have the Portuguese title of "Agregado";
- d) 8 copies of their cv in a digital format indicating the works they have done and published and the activities they have undertaken regarding all the functions the university teachers mentioned in point 4 of the ECDU are required to undertake;
- e) 8 copies of each of the works they have published that are mentioned on their cv, preferentially in digital format, namely the ones that are most representative of their contribution towards the development and progress in the subject areas the call for applications was opened for;
- f) Research and pedagogical statement that the applicant intends to adopt in the future - with no more than 5,000 words to be assessed under the scope of the scientific performance and pedagogical ability.

3 - The documents proving the applicants meet the general requirements for public sector recruitment may be submitted by a declaration made on the form mentioned in 2 a) above.

4 - The applications, along with the documents mentioned in point 2 above, must be sent within 30 business days as of the day immediately after this Notice is published in the 'Diário da República'.

5 - The lack of any of the documents providing proof that cannot be provided unofficially, will imply the application being rejected.

IV - Assessment criteria: The jury has approved the following criteria, indicators and weightings to assess and rank the applicants:

1 - In the Scientific Development Area, development and innovation (45 %):

- 1.1 - Publication of scientific articles and books;
- 1.2 - Coordination and participation in research projects;
- 1.3 - Management of research units;
- 1.4 - Communications presented at scientific congresses and conferences;
- 1.5 - Participation on the bodies of scientific magazines and on scientific award juries;
- 1.6 - Participation in scientific commissions, organisations or networks;
- 1.7 - Prizes and awards.

2 - In the Pedagogical Ability Area (45 %):

- 2.1 - Curricular Units they have coordinated and taught, taking into account the diversity (materials and study cycles) the pedagogical practice and the number of students;
- 2.2 - The publication of lessons and other teaching material;
- 2.3 - Thesis supervision;
- 2.4 - Active participation on juries for academic tests and teaching and research career applications;
- 2.5 - Prizes and awards.

3 - Other relevant activities (10 %).

- 3.1 - In the area of extension, namely in providing services to the community, patents registered, spin-offs created, scientific disclosure activities, training schemes;
- 3.2 - In the academic management area, namely posts held on University and Organisational Unit bodies, coordination of departments, sections and courses, other temporary posts and tasks.

4 - The assessment of the applications shall pay particular attention to the works and activities conducted in the area of the call for applications in the five years before the call for applications was launched.

5 - The applicant's national and international activities plan will always be taken into consideration.

V -Composition of the jury: The jury appointed by order of the dean on 5/02/2018 is composed of the following members:

Professor José João Gordo Nunes Abrantes, Full Professor of Universidade Nova de Lisboa Law School.

VI - Evaluation of the applications:

1 - After the deadline for the applications, the jury shall meet to assess and rank the applicants.

2 - Based on the appreciation of the curricula, their adequacy to the scientific area the call for applications was opened for and the other documents and classifications, as per the criteria and weightings provided in point IV above, the jury shall admit the applicants with a final classification on absolute merit of 50 or higher and reject any with a final classification of less than 50.

3 - If any applicant is not admitted, they shall be notified to respond pursuant to the Administrative Procedure Code.

4 - Once the applicants who are admitted have been decided, based on the classifications above, the jury shall present a written opinion with the ranking of the admitted applicants.

5 - The ranking of the applicants is made by the votes of the members, respecting the ranking presented in the document referred to in the previous point, pursuant to article 16(11) of the University Teaching Career Call for Applications Regulation of the UNL.

6 - If any of the applicants are excluded, there shall be a preliminary hearing, pursuant to article 122 *et seq* of the Administrative Procedure Code.

VII - In compliance with article 9 h) of the Portuguese constitution, the Public Administration, as an employer, shall actively promote a policy of equal opportunities between men and women in access to employment and in the professional progression, scrupulously avoiding all and any form of discrimination.
