### SHORT CV OF THE SUPERVISOR

Ana Falcato holds a PhD in Philosophy from the NOVA/FCSH, Lisbon, Portugal. Between 2013 and 2015, she was a Humboldt Research Fellow at the Johannes-Gutenberg University and the University of Oxford. Her work has appeared in Studies in the Novel, Hypatia: A Journal of Feminist Philosophy, Kant-Studien, Wittgenstein-Studien, Daimon: Revista International de Filosofía, Cosmos&History or the Deutsche Zeitschrift für Philosophie. She published Philosophy in the Condition of Modernism in 2018 with Palgrave Macmillan and Phenomenological Approaches to Intersubjectivity and Values in 2019 (published with Cambridge Scholar Publishing and co-edited with Luís Aguiar de Sousa). In 2021 appeared her edited collection The **Politics** of Emotional Shockwaves, again with Palgrave Macmillan (https://www.palgrave.com/gp/book/9783030560201). In 2023 shall appear, with Routledge, her new volume of essays: The Philosophy and Psychology of Delusions: Historical and Contemporary Perspectives. (Ed. Ana Falcato & Jorge Gonçalves).

# PROJECT TITLE AND SHORT DESCRIPTION

#### Mass Media and Gratuitous Violence

The main goal of this project is to raise awareness to the pernicious effects of the use and abuse of the internet by the younger generations. Children and teenagers learn to master a complex toolkit of digital resources at a moment in life when critical faculties are scarcely awake but information is very quickly processed. Our educative systems stimulate the uncritical trend of implementing plans for digital education as early as in primary school, when not earlier (Cf: Ranieri, 2017). Precisely due to the immediacy that allows information and misinformation to spread on social media, recent events in Europe, the US or in Latin America, in North Africa and the Middle East, have proved social media to be a powerful weapon in the global assault on democracy (cf: Kellner, 2016; Vaidhyanathan, 2018).

Our aim with this project is to carefully scrutinize current educational plans in several countries in the EU, but ultimately advocate that only a return to traditional models of education and tutoring can rescue new generations of web-addicted citizens from a source of threats that is too appealing to be seen as such. In that respect, the ultimate goal of the project is conservative to its roots.

Research does rely heavily on theoretical background, but seeks actively for sources of empirical evidence, in favor (or against) the fundamental hypothesis under analysis. So as not to contradict, methodologically, the deep skepticism that informs its leading hypothesis, and systematically base our work on digital sources, this last effort is specially meant to cover an on-the-ground acquaintance, by the PI, with daily routines in public and private schools in several European countries, as well as with annual strategies, developed by school committees, governmental agencies and the local power to organize the school-time of the so-called 'born-digital' citizens.





With its set of reforming social targets and principled educative mission, this project is a great fit for the UN 2030 Agenda for Sustainable Development, especially regarding Goal 4 and 16 of the Sustainable Development Goals (https://www.un.org/ga/search/view\_doc.asp?symbol=A/RES/70/1&Lang=E).
