PROJECT TITLE AND SHORT DESCRIPTION

Environmental History and the Sea

To study the past of the oceans and of marine populations resourcing to the analysis of early modern Iberian historical sources (Written, iconographic and cartographic) to address human impacts in the Iberian Peninsula as well as in the extra-European regions of the Portuguese and Spanish Empires. This will be achieved by employing integrative, transdisciplinary and cross-cultural approaches to the sources and the scientific questions (the construction of early modern natural history and philosophy; the marine environmental history of coastal and oceanic ecosystems and aquatic megafauna; past perceptions and local and global worldviews about nature; historical relationships between humans and non-humans).

Part of this research is included in the Work Package 'Maritime Spaces and Environments and the Exploitation of Marine Resources' of the European project CONCHA – The construction of early modern global Cities and oceanic networks in the Atlantic: An approach via Ocean's Cultural Heritage (H2020-MSCA-RISE-2017-777998), and is also developed within the framework of the UNESCO Chair Ocean's Cultural Heritage.
