Paula Borges Santos completed a degree in History from the Faculty of Social Sciences and Humanities of the New University of Lisbon (NOVA FCSH) in 2012. She is a Principal Researcher (CEEC Individual) at the Portuguese Institute of International Relations of NOVA FCSH, and Visiting Assistant Professor at the Faculty of Arts of the University of Coimbra. She directed the Justice, Regulation and Society Research Group there (2015-2020). She was a visiting professor at the Pontifical Catholic University of Rio Grande do Sul (2015 and 2020). She has been distinguished with 3 awards. She has participated in research teams on 11 projects and led 3 as the investigator-in-charge, and is currently co-responsible investigator of 1 Luso-Brazilian project and a member of the working team on 3 international projects (based in Spain). She has supervised master's theses and is currently directing doctoral theses and master's dissertations. A scholar of the phenomena of authoritarianism and the emergence of democracies, she has published extensively (4 books as author, 13 books as editor, 27 articles in scientific journals indexed in international catalogues, 22 book chapters, 63 entries in dictionaries, 8 dossiers in scientific journals as editor) on authoritarian political institutions, constitutionalism, labor regulation, politics and religion.
