# PROJECT TITLE AND DESCRIPTION

#### PROJECT A:

# Political Legitimacy in Times of Crisis: Governance Reforms in the Economica Monetary Union of the European Union

Investigates into the legitimacy requirements of different models of political and economic integration in the context of the EU economic governance reforms. Knowledge of the institutional architecture of the Economic and Monetary Union of the EU is required. Knowledge of EU integration theories is a baseline requirement.

### PROJECT B:

#### The Governance of Migration and Asylum: Duties of Assistance and the EU reception policies

Investigates into the duties of assistance and reception of asylum seekers in the context of the current migration wave from Asia and Africa. It aims to assess whether and how much the EU asylum system complies with those duties and what is the expected impact of the foreseen governance reforms in the field. Special attention is devoted to the Portuguese newly restructured asylum system. Researchers from abroad are not expected to participate in this specific section of the project, although they are welcome to do so, if they wish. Knowledge of the EU asylum system is required. Knowledge of the philosophical debate on duties of assistance is a baseline requirement.
