PROJECT TITLE AND DESCRIPTION

Regulation and Organized Interests in Europe (1900-2020)

The main objective is to investigate the socio-economic and political impact of organized interest associations within the European context, mapping and analysing their role in the building of national and European policies during the 20th Century. In that respect, the main goal of the project is to apply an interdisciplinary and long-term historical perspective, providing the necessary insights in order to deepen our understanding of the mechanisms behind the relationship between organised interest associations – such as industrial organisations, trade unions etc. – and politics. The analysis is precisely focused on the functions of the socio-economic organisations in the emergence, growth and developing of social and fiscal policies during the 20th Century, first in the various national environments and then in the context of the European Union.

Topics: a) mapping the rise and increasing importance of organised interest associations in Europe from the beginning of the 20th Century to our days; b) identifying and classifying the juridical structures and operative modalities applied by these associations in order to reach their objectives in the given timeframe; c) analysing the form of interaction, influence and lobbying – that is, in general, the relationship between organised interests and politics – existed in the European countries before and after the emergence of the European Union, specifically regarding economic, fiscal, social and labour legislation.

OTHER RELEVANT INFORMATION

The Research Group develops historical studies that address the cultural dimension of the law and the institutions policy about economic and social behaviors. Our studies follow different approaches to institutions, law and justice in an interdisciplinary environment, and examine national and transnational trends. The transnational dimension has been cultivated through training seminars on political and justice European history, which have provided the tools that allow for sustained comparative approaches; and also through our researcher's participation in international scientific projects. We also benefit from partnerships, consolidated through different scientific initiatives (publications, postgraduate training, scientific meetings, international scientific networks) from foreign research centres and universities, namely in Italy, Spain, France, Greece, Poland and Brazil. Our researchers maintain, in the works they develop, a regular cooperation and dialogue with entities from the central and local administration of the Portuguese State and with institutions of civil society. Our research revolves around 5 main axes: I) Justice and the protection of fundamental rights; II) Prevention and criminal investigation: memory, heritage and visual culture; III) Regulation and organized interests; IV) Governance and representation; V) Politics, law and religion.
