#### SHORT CV OF THE SUPERVISOR

PhD in Early Modern History (Universidad Autónoma de Madrid), I was trained in historical sociology, and specialized in social conflicts in Spain in comparative perspective. My overall interests deal with the sources of individual and collective action in historical contexts, which I analyse through a range of perspectives from conceptual history and intellectual history to theories of identity and of emotions. I have been Visiting Fellow at the Center for Social Theory and Comparative History (UCLA) and Visiting Professor at Sabanci University (Istanbul) and Université Bordeaux-Montaigne. I have been teaching history of social movements at Universidad Complutense de Madrid but mainly work as a researcher at University of the Basque Country.

In the last years I have been working on the language of modern citizenship in Spain and on concepts and experiences of time. My current topics of interest are the rise of modern individualism and the overcoming of imperial decadence in Spain and Portugal in comparative global perspective. I'm also involved in projects on the Gran narratives in Spanish history.

# FROM DECAYED EMPIRES TO TRADING NATIONS: THE CULTURE OF COMMERCE AND THE FRAMEWORK OF CITIZENSHIP IN SPAIN AND PORTUGAL, 1670s-1820s

The historical trajectories of Portugal and Spain in the early modern period have two features in common: their experience, throughout the 17th century, as declining imperial powers; and their parallel struggle, in the 18th century, with various Northern European empires that incorporated commerce as a rising source of wealth and hegemony. The forging of Portugal and Spain as 'nations' was shaped by these shared processes.

Covering from the 1670s to the 1820s, this project aims at examining how Portugal and Spain strove to overcome decadence. It will give centre stage to the culture of commerce extending in that period. Its main hypothesis is that the "science of commerce" deeply impacted on three main spheres of collective life: the self and its representations; the social order and its ranking; and the reshaping of the community as a 'nation'. This study will explore the extent to which changes in these spheres influenced the rise of the modern individual, of capitalist society and of citizenship.

The survey will particularly focus on how merchants, both as individuals and as part of their corporations, were re-signified as epitomes of the new patriotic values referring to trade. Developed in the wake of the Enlightened reforms, this emerging appreciation underscored the benefits of commerce over civilization and public happiness; yet, under changing political contexts, it also triggered path breaking struggles for citizenship.
