# PROJECT TITLE AND SHORT DESCRIPTION

Project title: South-South Solidarity and the National Liberation Movements from Portuguese Colonies, 1963-1975

The research project "South-South Solidarity and the National Liberation Movements from Portuguese Colonies, 1963-1975" is a collaborative initiative, involving multidisciplinary researchers from African, Brazilian and European universities. The project aims to build on current discussions in international history by studying South-South solidarity towards the struggle against Portuguese colonialism in Africa. The innovative contribution of the project will result from the analysis of the dynamics of the Organization of African Unity (OAU) support to the Portuguese colonies. Established to fight colonialism and white minority rule, the OAU championed the rhetoric of self-determination and equality among nations to challenge Portuguese colonial rule. Nevertheless, while for instance the United Nations initiatives on the Portuguese colonial issue have attracted much interest, the OAU support to the independence of Portuguese colonies has been a marginalized topic. By focusing on the OAU solidarity with the national liberation movements, the project intends to consolidate the body of knowledge about the African post-colonial states foreign policy.
