**Public Notice no. 14796-A/2021, August 9**

Summary: New deadline for applications in several job opening procedures

In accordance with the Public Notice no. 719/2021 published in *Diário da República*. 2nd series, number 122, June 25, it was announced that for a period of 30 business days counting from the day of the referred Public Notice in *Diário da República*, an international job announcement was opened for the recruitment of an Associate Professor in the area of History, subarea of Modern History and History of the Portuguese Expansion, with a relevant curriculum in Environmental History, Globalization and History of Science in the Modern Period at NOVA School of Sciences and Humanities.

In accordance with the Public Notice no. 720/2021 published in *Diário da República*. 2nd series, number 122, June 25, it was announced that for a period of 30 business days counting from the day of the referred Public Notice in *Diário da República*, an international job announcement was opened for the recruitment of an Assistant Professor in the area of Letters, subarea of Classical Studies, preferably with a relevant curriculum in the field of Latin Culture and Language at NOVA School of Sciences and Humanities.

In accordance with the Public Notice no. 721/2021 published in *Diário da República*. 2nd series, number 122, June 25, it was announced that for a period of 30 business days counting from the day of the referred Public Notice in *Diário da República*, an international job announcement was opened for the recruitment of an Assistant Professor in the area of Linguistics, preferably with a relevant curriculum in the field of Portuguese as a second or foreign language at NOVA School of Sciences and Humanities.

In accordance with the Public Notice no. 722/2021 published in *Diário da República*. 2nd series, number 122, June 25, it was announced that for a period of 30 business days counting from the day of the referred Public Notice in *Diário da República*, an international job announcement was opened for the recruitment of an Assistant Professor in the area of Letters, subarea of Translation Studies, with an especially relevant curriculum in translation of business affairs at NOVA School of Sciences and Humanities.

In accordance with the Public Notice no. 759/2021 published in *Diário da República*. 2nd series, number 130, July 7, it was announced that for a period of 30 business days counting from the day of the referred Public Notice in *Diário da República*, an international job announcement was opened for the recruitment of a Full Professor in the area of History of Art, with an especially relevant curriculum in the fields of Contemporary Art History in Portugal and Museology at NOVA School of Sciences and Humanities.

In accordance with the Public Notice no. 773/2021 published in *Diário da República*. 2nd series, number 132, July 9, it was announced that for a period of 30 business days counting from the day of the referred Public Notice in *Diário da República*, an international job announcement was opened for the recruitment of an Assistant Professor in the area of Social Sciences with an especially relevant curriculum in the field of

interdisciplinary studies of Sociology and Global History of Work in the 20th and 21st centuries at NOVA School of Sciences and Humanities.

Considering that according to the Dispatch 3012/2015, February 20, published in *Diário da República*, 2nd series, number 58, March 24 (NOVA University Regulation for University Teacher Career Applications), the international procedures are published in *Eracareers*.

Considering that, by the time these announcements were published in *Diário da República*, it was not possible to publish the above mentioned international job opening procedures in *Eracareers*, once the website was in process of being discontinued.

Considering that *Eracareers* was substituted by *Euroaxess*, the doubt – whether these procedures for the recruitment of Professors must be published in this new platform – remains. Nonetheless, a current interpretation of NOVA University Regulation for University Teacher Career Applications fulfills the obligation of publishing in an international platform.

Considering that the non-publication in *Euroaxess* might be considered irregular and that could consubstantiate a limitation to the opportunity of the interested candidates to apply.

It becomes public that, by my decision on August 5, 2021, it has been given a new deadline of 30 business days to the submission of applications to the above mentioned job opportunities procedures counting on the day of the publication in *Euroaxess* which occurred on August 6, 2021 and goes until September 17, 2021, for each procedure.

All the candidates who have already send an application are exempt from submitting a new one, although it is possible to add documents to the applications within the new deadline.
