#### SHORT CV OF THE SUPERVISOR

Dr. Felipe Pathé Duarte is Assistant Professor at Nova School of Law, specializing in Political Science, International Relations, and Security Studies, where he coordinates both the PhD and Master's programs in Law and Security. He is also cofounder and director of the Knowledge Centre War and Law LAB, which is part of the Research & Development Centre in Law and Society (CEDIS), where he holds the position of Deputy Director. Appointed by the European Commission, Dr. Pathé Duarte serves on the EU Knowledge Hub Research Committee on the Prevention of Radicalisation and Extremism, providing strategic guidance and policy recommendations. Additionally, he is a researcher with the European Research Community on Radicalisation (ERCOR) and an active participant in the European Expert Network on Terrorism Issues (EENeT). His affiliations also include the Association for the Study of the Middle East and Africa (ASMEA). In the media, Dr. Pathé Duarte has been an exclusive international security analyst for RTP (the public TV network) since 2016, contributing regularly to programs such as Jornal2 (RTP2), where he provides geopolitical analysis during prime-time slots. Dr. Felipe Pathé Duarte holds a PhD in Political Science and International Relations (specializing in Security and Defence) from the Portuguese Catholic University, with research conducted at Oxford University and the Center for Strategic and International Studies (CSIS) in Washington, D.C. His academic background includes a Master's in Political Science and a degree in Philosophy from the University of Coimbra. His research focuses on political violence, insurgency, violent non-state actors, and the geopolitical implications of extremism, making significant contributions to both academic and policy-oriented discussions.

## PROJECT TITLE AND SHORT DESCRIPTION

### War and Law – The Future of Conflict

War is like a chameleon, as Clausewitz once described. While it may change in form, its essence remains constant. Although motivations, technological advancements, and tactical or strategic innovations evolve, the fundamental nature of war does not change. In this context, the legal and geopolitical dimensions of warfare are just a few of the many aspects that define the state of war, and they undergo continuous processes of mutation and adaptation. This multidisciplinary project aims to analyse and study the changes in armed conflict and their various consequences, particularly concerning policies, governments, and institutions. It addresses current trends in armed conflicts and the challenges they pose for these governing bodies. The project also considers key factors that can help us understand the future of conflict, particularly in relation to creating conditions for peace.

The project has four main areas of analysis:

- Digital technologies and hybrid warfare
- Climate change and resource competition
- Non-state armed groups and the privatisation of conflict
- Identities, radicalisation, and violent extremism
